**Treasurers Report**

- 1. I have confirmed with Andro that the TAN funds will be available shortly after we make a request
- 2. We have received notice that \$18,216 of Fema/Mema funding has been awarded. The funds have not been released to us yet.
- 3. Ads in CDS and Bridgton were placed for road paving bids
- 4. Road expenses, including rough estimates for the work planned, would total \$170k for the year. We had a budget of \$282k.
