Streetlight – S.Dupuis has tried to contact CMP to repair the streetlight.

Bear Dyer will submit a quote to paint the guardrail before winter sets in.

The fiber optic installers have material at the salt shed. S.Dupuis will call and ask them to remove it within the month.
